Call to order at 7:03 pm with devotions and prayer.

1. Consent Agenda: Motion to accept the consent agenda made by Cindi and seconded by Michelle. Motion carried.
2. Treasurer Report: We had service charges for September on our account because we had a commercial account, not a non-profit. Cindi got that changed so we won't get any more. We should be getting a bill from Ministry Manager. There was also a fee for the showers, and Liability insurance on the Chrysalis trailer, which is \$428.00. Wendy made a motion to accept the treasurer's report, seconded by Amy. Motion carried.
