Things I need to know:

What is the deadline for sponsoring a Pilgrim?

Once the minimum number (20) of registrations are received, more registration forms will be accepted until the maximum number of registrations are received (36 for a full walk) or until 2 weeks prior to the walk. If more than 36 registrations are received for any walk, the additional registration forms will be put on a waiting list in the order received in case there are cancellations, or the applicants will be given the option of pre-registering for the next walk.

Scholarships:

There are limited funds available for partial scholarships for Pilgrims who are experiencing financial hardship. Scholarship application forms are available from the Registrar and should be submitted along with registration forms. Scholarships up to \$50.00 per request may be approved as resources allow.
